What initially brought me to Haiti in 2004 was an attempt to save on airfare. I flew Air France from Miami and arranged transport from Port au Prince to the border town of Malpasse where I boarded a bus to Santo Domingo.

When I arrived in Haiti I was pained by the poverty of the people living in

Haiti. I had visited other third world countries in Central America, the Caribbean and West Africa but I had never imagined the suffering associated with the impoverishment as I witnessed in Haiti. I began to understand why the Haitian people would risk life and limb to travel to America.

My interest in Haitian and African art brought me back to Haiti in 2005 where I visited an artist's colony on the southern coast in the town of Jacmel. Before making the trip, I asked friends and family members for clothing donations to take with me and donate to a local church. The gratitude of the people in the church was enough to make me want to do more. On my next visit in 2007, I went to the flea market and purchased 5 duffel bags, filled the bags with clothing and toiletries from the dollar store and delivered them to Bethel Adventist Church in Port au Prince to a very grateful congregation.

I look forward to planning another trip so don't throw away your used clothing. There are people who would be very grateful to have them.
